

Meet Ward Stockamp: Central State's Safety and Human Resources Director

Ward Stockamp has been the Safety & HR Director at Central States Enterprises for the past 4 years, and has been in the business of safety for 23 years.

C tockamp's education and **J**technical background are impressive: Kansas State University Environmental Engineering courses, ISO 14001 Lead Auditor: RAB certified, ISO9001 Internal Auditor, TS16949 Internal Auditor, Army Ammo-62 certified (Technical transportation of hazardous materials), Army Radiation Safety Officer (RSO), Federal Express Dangerous Goods, and OSHA Outreach Trainer for General Industry (10 and 30 hour).

What is your focus on Safety & HR now and in the future?

Staying abreast of the regulatory landscape, and how that impacts our business model and operations. It is a daily, weekly, to monthly monitoring situation, and I pride myself on being proactive.

What is something you bring to the table that our competitors do not have?

I'd say it's my background. I've worked in heavy industrial manu-

facturing facilities with 1,000 employees on site, law enforcement, retail safety and Department of Defense contracting. I've been through several variations of quality systems, safety systems, and environmental systems management training and been dealing with federal regulations for a long time. With my diverse background I've learned to adapt and apply novel solutions to safety problems.

Anything else you would like Ato say?

I really enjoy the culture of safety we have built here at CSE. When I show up unannounced to perform an audit, and I have to dig to find something to write down, that gives me a sense of accomplishment. I know our crews work hard and have a very busy workload, but if I have to dig to find anything wrong, that tells me that safety is built in to what we do and they are doing things right even when no one is watching. When a brand new employee takes me aside a week or so into the job and tells me how his On-the-Job Trainer points out a safety violation, and tells him flat out that is not how we do things around here, and how that has never happened anywhere else they have worked - that makes my day.
